Item A: Approve/Disapprove any and all matters concerning the water purchasing project to include but not limited to:

Approve/Disapprove changing the City's Classification

Alderman Slusher clarified why the City wished to change from a Type B city to a Type A city. Mayor Gillespie explained the significant differences between Type B and Type A. Alderman Ehmann made the motion to accept and approve Ordinance No.2013-02 Providing for a Change of the Status of the Town from a Type B General Law City to a Type A General Law City. Alderman Robbins seconded the motion. The motion passed unanimously.

• Approve/Disapprove Contract for Engineering Services with J Schwarz & Associates, Inc.

Discussion occurred covering the proposed contract and the addendum to the contract. City Attorney Hal George stated he has discussed the addendum with the Engineer and any changes concerning the insurance has been worked out. The addendum needs a few minor corrections. Alderman Ehmann made the motion to approve the Agreement for Professional Engineering Services subject to the revisions concerning insurance. Alderman Robbins seconded the motion. The motion passed unanimously.

• Approve/Disapprove a Financial Advisory agreement with RBC Capital Markets
