## CITY OF INGLESIDE ON THE BAY CITY COUNCIL MEETING September 24, 2013

- I. City Council Meeting was called to order by Mayor Gillespie at 7:00 p.m.
- II. Alderman Ehmann gave the invocation.
- III. Mayor Gillespie led the Pledge of Allegiance.
- IV. Roll Call: Present were: Mayor Gillespie, Alderman Tucker, Merrick, Ehmann, Robbins and Skinner.
- V. Minutes of Previous Public Hearing and City Council Meeting of September 3, 2013 were approved as written.
- VI. Treasurer Report was given.
- VII. No Citizen Participation was heard.
- VIII. Reports from Standing Committees
  - Item A: Planning & Zoning had no report.
  - Item B: Parks & Recreation had no report.
  - Item C: VFD reported no calls were responded to; Travis is testing for certification 1 and 2; the ISO (insurance rating organization) visited the VFD and they are waiting for the results of the inspection.
- IX. Old Business: Discussion and Possible Action

Item A: Review and award 8" Waterline Project Construction Contract
Mayor Gillespie went over the bids and the engineer's recommendation. The second bid saved the
City approximately half a million dollars. Both projects will cost approximately 1.5 million dollars.
Ground breaking should be within three weeks. Alderman Robbins made the motion to award the
contract to Mercer Construction Company in the amount not to exceed \$689,698.00. Alderman
Ehmann seconded the motion. The motion passed with Alderman Robbins, Ehmann, Tucker and
Merrick voting in favor of the motion. Alderman Skinner abstained from the vote.

Item B: Review and make changes as necessary to Ordinance 2007-05 Establishing Animal Control, not limited to but including the establishment of the position of City Animal Control Officer.

Alderman Ehmann explained the changes made to Ordinance 2007-05. Alderman Ehmann made the motion to approve Ordinance 2013-09 Establishing Animal Control Regulations; Repealing Ordinance 2007-05 and Providing a Penalty for Violations. Alderman Skinner seconded the motion. The motion passed with Alderman Skinner, Ehmann, Tucker and Merrick voting in favor of the motion. Alderman Robbins abstained from the vote.

## X. New Business: Discussion and Possible Action

Item A: Approve/Disapprove Ordinance Adopting and Approving the 2013 Certified Appraisal Tax Roll

The City Secretary stated corrections in the Tax Rolls have been sent to the Appraisal District. Alderman Ehmann made the motion to approve Ordinance 2013-08 Adopting and Approving the 2013 Certified Appraisal Tax Roll. Alderman Tucker seconded the motion. The motion passed unanimously.

Item B: Grover Ferdon's request to discuss residence located at 729 S Starlight Grover Ferdon was not present. No Action was taken. Mayor Gillespie removed the item from the agenda.

Item C: Grover Ferdon's request to discuss Bayshore Circle Grover Ferdon was not present. No Action was taken. Mayor Gillespie removed the item from the agenda.
