- I. City Council Meeting was called to order by Mayor Gillespie at 7:00 p.m.
- II. Alderman Ehmann gave the invocation.

XI. New Business: Discussion and Possible Action

Item A: Discuss/take action on above item regarding the purchase of real property located at Block 121 Lots 1 through 4; corner of Seagull Lane and Live Oak Street.

Wayne Jewell asked if the current sewer system pumps can be reversed to accommodate placing the sewer plant on the property in question. He also asked how the property would be paid for. Mayor Gillespie stated the current system could not be reversed and the property would be paid for out of reserve funds.

Idana Merrick stated her concerns about the plant itself, there are places where there is a sewer plant and it was not even noticeable as a sewer plant. A plant can be built to prevent odors and unsightly views.

Mayor Gillespie stated if a sewer plant needs to be built it would only be 50x50 feet, but needs 150 feet between it and any residential property. There may not be a sewer plant; the property is for possible future use.

Discussion continued covering price and the time frame for purchasing the property. Alderman Tucker made the motion to authorize Mayor Gillespie to enter into negotiations and contract to purchase the property. Alderman Gillespie seconded the motion. The motion passed unanimously.

Item B: Approve/Disapprove Resolution 14-257 Appointing Mayor Pro-Tem for the 2014 Term Year Alderman Robbins nominated Alderman Tucker for Mayor-Pro-Tem. Alderman Tucker declined and made the nomination and motion to appoint Alderman JoAnn Ehmann as Mayor-Pro-Tem. Alderman Merrick seconded the motion. The motion passed with Alderman Tucker, Merrick, Ehmann and Gillespie voting for the motion and Alderman Robbins voting against.

Item C: Approve/Disapprove Resolution 14-258 Appointing Treasurer for the 2014 Term Year Alderman Ehmann nominated and made the motion to appoint Alderman Tom Merrick as Treasurer. Alderman Tucker seconded the motion. The motion passed unanimously.

Item D: Approve/Disapprove Resolution 14-259 Appointing Official Newspaper for the 2014 Term Year

Alderman Ehmann made the motion to appoint the Ingleside Index as the Official Newspaper. Alderman Robbins seconded the motion. The motion passed unanimously.

Item E: Approve/Disapprove Resolution 14-260 Appointing Official Costal Bend Council of Governments Representative for the 2014 Term Year

Alderman Merrick nominated and made the motion to appoint Alderman Jo Ann Ehmann as the Official Costal Bend Council of Governments Representative. Alderman Robbins seconded the motion. The motion passed unanimously.

Item F: Approve/Disapprove Resolution 14-261 Appointing VFD Financial Director for the 2014 Term Year

Alderman Merrick nominated and made the motion to appoint Alderman Jo Ann Ehmann as the VFD Financial Director. Alderman Gillespie seconded the motion. The motion passed unanimously.
