Item B: Approve/Disapprove Ordinance Providing for Recreational Vehicle and Trailer Requirements

Alderman Robbins stated she felt the city should not allow storage on any vacant lots. Travis Morin stated the city should not force what the citizens can do on their own property. Mayor Gillespie tabled this item until input from the City Attorney could be received.

Item A: Approve/Disapprove appointment of four members to the Planning and Zoning Commission Alderman Ehmann thanked everyone who applied. Alderman Ehmann made the motion to reappoint Jane Hunt and Art Foss and to appoint Idana Merrick to the Planning and Zoning Commission. Alderman Robbins seconded the motion. The motion passed with Alderman Ehmann, Tucker, Merrick and Gillespie voting in favor and Alderman Robbins voting against.

Alderman Ehmann made the motion to approve the pass through rate increase from Allied Waste.

Alderman Gillespie seconded the motion. The motion passed unanimously.
