

AN ORDINANCE *1998-02*  
AMENDING ORDINANCE NO. 93-05 PROVIDING  
FOR MINIMUM FLOOR AREA LIMITATIONS;  
PROVIDING ORDINANCE 93-05 CONTINUES IN EFFECT;  
PROVIDING A PENALTY; PROVIDING FOR PUBLICATION

**BE IT ORDAINED BY THE CITY COUNCIL OF INGLESIDE ON THE BAY, TEXAS:**

SECTION 1. That Ordinance 93-05 is amended by amending Section 2 thereof to hereinafter read as follows:

"SECTION 2. No building shall be permitted on any lot within Ingleside on the Bay unless it complies with the standards established by this Ordinance. The enclosed and finished living area of the main building or dwelling shall contain a minimum of one thousand (1000) square feet."

SECTION 2. All other parts of Ordinance 93-05 shall remain in full force and effect it being the intention of the City Council to keep such Ordinance in full force and effect as amended herein.

SECTION 3. Any person, firm or corporation who shall violate this Ordinance shall be guilty of a misdemeanor and shall be deemed guilty of a separate offense for each day thereof during which any violation hereof is committed, continues or is permitted, and upon conviction of any such violation shall be punished by a fine not to exceed two hundred dollars (\$200.00) and not less than seventy-five dollars (\$75.00) per violation.

SECTION 4. This Ordinance shall be effective from and after the publication of the caption thereof in the official newspaper.

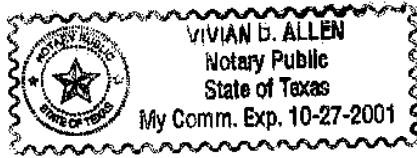
