ADOPTING THE BUDGET FOR THE NEXT FISCAL

SECTION II. That the budget, as shown in words and figures in Exhibit A, is hereby approved in all respects and adopted as the City's budget for the fiscal year beginning October 1, 2000 and ending September 30, 2001.
