## ORDINANCE NO. 2008-02

AMENDING ORDINANCE 2006-02 PROVIDING FOR A RATE SCHEDULE OF PAYMENT OF BILLS; ORDINANCE 2006-02 CONTINUES IN EFFECT; PROVIDING FOR PUBLICATION

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF INGLESIDE ON THE BAY:

SECTION I. That Ordinance 2006-02 is amended by amending Section 7 thereof to herein after read as follows:

"Section 7. MONTHLY WATER RATES

First 2,000 gallons

\$ 47.83

Each additional 1,000 gallons

\$ 6.86

All active meters will be subject to the minimum monthly charge.

All out of City limit customers will be charged the same rate as in City customers for water and sewer rates. Sewer rates are established by Ordinance 2003-05 or by the most current amendment to said ordinance.

SECTION 2. All other parts of Ordinance 2006-02 shall remain in full force and effect, it being the intention of the City Council to keep such Ordinance in full force and effect as amended herein.

SECTION 3. This Ordinance shall be effective upon adoption and publication of the caption thereof in the official newspaper of the City.
