ORDINANCE NO. 2013-02

AN ORDINANCE

OF THE CITY OF INGLESIDE ON THE BAY, TEXAS, PROVIDING FOR A CHANGE OF THE STATUS OF THE TOWN FROM A TYPE B GENERAL LAW CITY TO A TYPE A GENERAL LAW CITY.

WHEREAS, Chapter 6, Subchapter B, of the Texas Local Government Code authorizes a general law city that is incorporated in any manner other than a Type A general-law city and that has more than six hundred (600) inhabitants or contains one or more manufacturing establishments within its corporate limits to change to a Type A general law city; and

WHEREAS, as of February 19, 2013, the City Council of the Ingleside on the Bay has determined that the City of Ingleside on the Bay has six hundred (600) or more inhabitants; and

WHEREAS, the City of Ingleside on the Bay was originally incorporated by election November 5, 1991, under the general laws of the State of Texas; and

WHEREAS, at least two-thirds of the governing body of the City of Ingleside on the Bay at a regular meeting have voted this day to change to a Type A general-law city.

NOW THEREFORE BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF INGLESIDE ON THE BAY, TEXAS, that:

Section 1. Ingleside on the Bay hereby changes from a Type B general-law municipality to a Type A general-law municipality.

Section 2. On February 19, 2013, in accordance with applicable statutory guidelines, the City of Ingleside on the Bay is granted all the powers and duties of a type A general-law city operating under the aldermanic form of government governed by Chapter 22 of the Texas Local Government Code; and in accordance with Chapter 6, Subchapter B, of the Texas Local Government Code, the City has this day became a Type A general-law city.

Section 3. The aforementioned two-thirds vote be recorded in the journal of the governing body's proceedings. A copy of this Ordinance and the record of this day's proceedings be signed by the Mayor. A copy of this Ordinance and the record of this day's proceedings be attested by City Secretary under the corporate seal. A copy of this Ordinance and the record of this day's proceedings shall be filed and recorded in the office of the County Clerk of San Patricio County, Texas.
